

BASES FOR THE SUBMISSION OF ABSTRACTS AND SUBMISSION OF ORAL COMMUNICATIONS AND POSTERS

GENERAL REGULATIONS

The presentation of works by the assistants supposes an active participation of the same ones, which, will be able to present their lines of investigation and results, at the same time as to contribute new data related to Occupational Therapy.

The submitted works must meet the following regulations to be admitted:

1. The works must belong to any of the areas related to Occupational Therapy.
2. Only original content will be accepted. The works must be unpublished and may not have been presented previously in other congresses or published in any scientific journal.
3. If the work done has received some funding or is part of a clinical trial, it must be duly specified. Any conflict of interest in relation to the work must be communicated by the authors.
4. Communications that are the product of the disintegration of a single work, or those that do not comply with internationally accepted ethical standards are not acceptable.
5. In order to present a communication / poster it is essential that at least the first author or the speaker, in the case of not being the same person, is enrolled in the VIII International Students Congress of Occupational Therapy of the Miguel Hernández University. Only those who have registered in the Congress will receive certification of authorship of the oral communication or poster.
6. The text of the summary and the presentation in any of the formats (oral communication or poster) will be done in Spanish, English or French.
7. Failure to comply with the rules will lead to the disqualification of the work, and a penalty that would lead to not being able to present any scientific work, by all authors, in this Congress in a period of 2 years.


SUBMISSION OF ABSTRACTS

The submission will be made through the form of Submission of Abstracts (click [here](#)) from **Monday, November 20 to Monday, April 23.**

The communication of acceptance of your work will be made through the email address provided through the form.

Rules for the preparation of the summary:

1. The summary must contain the following points:

- 
- a. **Title:** Must be short (maximum of 100 characters, with spaces) and specific.
Abbreviations can not be included in the title.
 - b. **Authors:** Name and surnames, as well as their affiliation, indicating the work center of the authors. If there are several, they will be distinguished by a superscript number.
 - c. **Text:** The maximum extension of the summary will be 3000 characters (with spaces).

The content of the summary will be written without repeating the title of the work and adjusting to the following scheme:

- Goals
- Material and methods
- Results
- Conclusion

2. The presentation preference must be specified: oral communication or poster. The Scientific Committee reserves the right to demand additional information about the presented summary, as well as the convenience of its oral presentation or in poster format until April 23, 2018.
3. Communications accepted as a poster will be displayed in the poster room during the three days of the congress. In addition, you will have 3 minutes of exhibition and 2 minutes of questions.
4. The accepted oral communications will be presented in the corresponding sessions, with a maximum duration of 10 minutes. Each oral communication session will have a 10-minute round table.
5. The maximum number of authors will be 6 authors per work.
